My first Passover in your city, as a baide with no family and no invitations for seder, I made a seder of my own, in my kitchen, and my husband found another stranger and invited him o our table. And that's the kind of Jew I am! It only imbarasses me that you nave displayed to the fine on-Jewish readers of his paper that isolated ockets of bigotry exist vithin the Jewish heriige of which I am so roud.
